Dear Illinois Reading Council Member,

Do you know a K-8 teacher and Illinois Reading Council member who teaches in a rural school who could make good use of a classroom library? If so, the Illinois Reading Council is honored to invite you to submit a nomination for the **Pamela J. Farris Rural Classroom Library Award**. The award was created in 2012 by a gift from Pamela J. Farris to the Illinois Reading Council.

Dr. Farris attended a small rural school as a child, and she later began her teaching career in rural schools. She notes that students in rural schools often lack access to public libraries, and they usually are not able to provide funding offered by larger school districts and towns for school libraries. This makes it difficult for rural teachers to offer a wide selection of high quality, interesting literature to students as they teach. Classroom libraries make a difference by providing such books. According to Pam, “By providing interesting books, students tend to read more and read better.”

This award provides the winning teacher with a classroom library, selected by the committee, to target the grade level and needs of the award-winning teacher. The library is designed to enhance the availability of quality literature for students to read. It will be valued at over \$500.00. The award will be open to all K-8 classroom teachers who teach in rural schools (town population less than 2,500) in Illinois.

Submit a nomination by completing the enclosed form by **March 1st**. Nominations must be made by current Illinois Reading Council members. Self-nominations are both permitted and encouraged. - Serving the Illinois Reading Council in its mission to support literacy development;
